

**BOOK SPECIFICATIONS**

Trim Size: 8 3/8" x 10 1/2" Bleed Size: 8 5/8" x 10 3/4" No live matter within 1/4" of final trim size. On spreads allow 1/8" safety on each side of the gutter. All marks should be offset at least .125" from trim. All ads supplied must be CMYK. For ads requiring a spot color, please contact your production manager for specifications.

**Binding:** Perfect Bound **Jog:** to Foot

**Supplied materials that do not comply with the following specifications will be corrected and the advertiser billed for the required production.**

**AD SIZES:** All ads must be created to exact size specifications listed on the rate card or will incur charges for resizing.

**\*Please supply spread files as a single spread document. Hold live matter 1/4" from trim on all sides of spreads and full page ads.**

**REQUIRED FORMAT:** PDF/X-1a format is the required file format for submission. When preparing PDF/X-1a files, careful attention must be paid to ensure they are properly created and will reproduce correctly. Please see <http://www.adobe.com/products/acrobat/standards.html> for guidelines and instructions. Files should conform to SWOP guidelines, and total ink density should not exceed 300%. View specifications online at [swop.org](http://swop.org).

**PROOFS:** For full page and spread ads, advertisers MUST submit a contract-level digital proof at full size that conforms to SWOP standards (including a color bar) for all digital files. Client-supplied contract proof is required to guarantee color. Acceptable contract

proofs include: Epson Contract Proof, IRIS, Kodak Approval, Digital Match Print, Progressive Press Proof, Fuji Pictro, Fuji Final Proof. Proofs are required regardless of file delivery mode. If contract proof is not supplied, we will generate an Epson proof, and additional charges may apply. The publisher and printer will not accept responsibility when contract proofs are not submitted.

**INSERTS:** Consult your advertising representative. Production, design and prepress services are available; rates upon request.

**Materials Requirements for In-House Design Services:**

**Photos:** Color scans should be 300 dpi in CMYK. B/W scans should be 300 dpi grayscale.

**LOGOS:** Vector .eps or .ai files are preferred. Type should be converted to outlines unless the fonts are provided. Jpgs should be 300 dpi.

**If you are supplying native files for us to work with, they must be accompanied by the fonts used in those files. Black type on light background should be defined as 100% black ONLY. Files should conform to SWOP guidelines, and total ink density should not exceed 300%.**

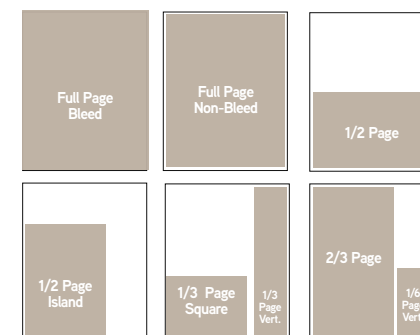
